

ORDINANCE NO. 2289

ORDINANCE AMENDING THE CODE OF ORDINANCES, CITY OF NEWTON, IOWA, 2016, TITLE VII, CHAPTER 70, SECTION 70.15, "TRAFFIC AND PARKING SCHEDULES ADOPTED BY REFERENCE" BY ADDING STOP SIGNS AT VARIOUS LOCATIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEWTON, IOWA:

Section 1. The Code of Ordinances, City of Newton, Iowa, 2016, Title VII, Chapter 70, Section 70.15 "Traffic and Parking Schedules Adopted by Reference" is hereby amended by adding or ~~deleting~~ the following:

SPECIAL STOPS REQUIRED. Every driver of a vehicle shall stop and yield in accordance with the following:

STREETS, NORTHWEST QUADRANT

West Fifteenth Street North. Vehicles traveling on West Fifteenth Street North shall stop at the following street intersections.

North Fourth Avenue West.
North Seventh Avenue West.

AVENUES, NORTHEAST QUADRANT

North Third Avenue East. Vehicles traveling on North Third Avenue East shall stop at the following street intersections.

First Street North.
East Fourth Street North.
East Eighth Street North.
East Thirteenth Street North.
East Twentieth Street North.
East Twenty-first Street North.
East Twenty-Third Street North.

North Fifth Avenue East. Vehicles traveling on North Fifth Avenue East shall stop at the following street intersections:

East Tenth Street North.
East Twelfth Street North.
East Nineteenth Street North.
East Twenty-first Street North.
East Twenty-Third Street North.
East Twenty-fifth Street North.

AVENUES, NORTHWEST QUADRANT

North Second Avenue West. Vehicles traveling on North Second Avenue West shall stop at the following street intersections.

First Street North.
West Second Street North
West Third Street North.
West Eighth Street North.
West Ninth Street North.
West Fifteenth Street Place North.

North Third Avenue West. Vehicles traveling on North Third Avenue West shall stop at the following street intersections.

First Street North.
West Eighth Street North, ~~Eastbound only.~~
West Eleventh Street North.
West Fifteenth Street Place North.

North Fifth Avenue West. Vehicles traveling on North Fifth Avenue West shall stop at the following street intersections

First Street North, Eastbound only.
West Third Street North.
West Seventh Street North.
West Eighth Street North, Westbound only.


Section 2. Repealer Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. Severability Clause. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective. This ordinance shall be effective on April 24, 2017, after the final passage, approval and publication as provided by law.
