

ORDINANCE NO. 2297

ORDINANCE AMENDING THE CODE OF ORDINANCES, CITY OF NEWTON, IOWA, 2016, TITLE VII, CHAPTER 70, SECTION 70.15, "TRAFFIC AND PARKING SCHEDULES ADOPTED BY REFERENCE" BY ADDING STOP SIGNS AND YIELD SIGNS AT VARIOUS LOCATIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEWTON, IOWA:

Section 1. The Code of Ordinances, City of Newton, Iowa, 2016, Title VII, Chapter 70, Section 70.15 "Traffic and Parking Schedules Adopted by Reference" is hereby amended by adding or ~~deleting~~ the following:

SPECIAL STOPS REQUIRED. Every driver of a vehicle shall stop and yield in accordance with the following:

STREETS, SOUTHWEST QUADRANT

West Fifteenth Street South. Vehicles traveling on West Fifteenth Street South shall stop at the following street intersections.
South Twelfth Avenue West, Northbound only.
South Thirteenth Avenue West.
South Twenty-fourth Avenue West.

West Fifteenth Street Place South. Vehicles traveling on West Fifteenth Street Place South shall stop at the following street intersections.
South Fifteenth Avenue West.

West Seventeenth Street South. Vehicles traveling on West Seventeenth Street shall stop at the following street intersections.
South Fifteenth Avenue West.

AVENUES, SOUTHWEST QUADRANT

South Third Avenue West. Vehicles traveling on South Third Avenue West shall stop at the following street intersections.
West Third Street South.
West Fourth Street South.
West Eighth Street South. [Ord. 2231 Eff. 05/09/2014]
West Twelfth Street South. [Ord. 2231 Eff. 05/09/2014]
West Thirteenth Street South, eastbound only.
West Fourteenth Street South.

South Fourteenth Avenue West. Vehicles traveling on South Fourteenth Avenue West shall stop at the following street intersections. [Ord. 2231 Eff. 05/09/2014]
West Sixth Street South. [Ord. 2231 Eff. 05/09/2014]
West Twelfth Street South. [Ord. 2231 Eff. 05/09/2014]
West Thirteenth Street South.

South Fifteenth Avenue West. Vehicles traveling on South Fifteenth Avenue West shall stop at the following street intersections.
West Fourth Street South.
West Seventh Street South, Eastbound only. [Ord. 2231 Eff. 05/09/2014]
West Ninth Street South.
West Twelfth Street South. [Ord. 2231 Eff. 05/09/2014]
West Thirteenth Street South.
West Fourteenth Street South.
West Sixteenth Street South. [Ord 2237 Eff. 10/28/2014]

SPECIAL YIELD REQUIRED. Every driver of a vehicle shall yield in accordance with the following:

West Fourth Street South. Vehicles traveling on West Fourth Street South shall yield at the following street intersections.

South 15th Avenue West, northbound traffic on the east frontage road of West Fourth Street South.
South 16th Avenue West, northbound traffic on the east frontage road of West Fourth Street South.

South Third Avenue West. Vehicles traveling on South Third Avenue West shall yield at the following street intersections.

West Thirteenth Street South, westbound only.

South Eleventh Avenue West. Vehicles traveling on South Eleventh Avenue West shall yield at the following street intersections.

West Twenty-second Street South.

South Sixteenth Avenue West. Vehicles traveling on South Sixteenth Avenue West shall yield at the following street intersections.

West Thirteenth Street South.

West Fourteenth Street South.


Section 2. Repealer Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed.


