a. Jasper County Removal of Bunkers & Flagpoles – Courthouse Square. Maki reported that Jasper County Maintenance Supervisor, Adam Sparks, had requested input from the SSMID board regarding the removal of the concrete bunkers on each corner around the Courthouse, as well as the disposition of the flagpoles. City Administrator Muckler suggested that input on the County project was needed from Public Works Director, Jody Rhone, and Community Services Director, Brian Laube. Pryke suggested that one flagpole per corner be kept, while Chair O'Brien noted that the SSMID board should draft a "wish list" for the County's corners to present to the Supervisors. Pryke also suggested that a flagpole, flower pot and bench be placed on each corner for the spring/summer seasons, removable in the fall/winter. Chair O'Brien requested that Jody Rhone, Brian Laube and Adam Sparks be invited to attend the next SSMID board meeting on September 14<sup>th</sup> for a further discussion. Main Street Director Yeager volunteered to listen to the next Supervisor's meeting and email any updates on this project to SSMID board members.

- b. Update on Floral Planter project (Yeager). All but four of the floral planters were sponsored.
